Dear Suppliers,

Hereby we inform, that according to Regulation (EC) no. 1907/2006 of the European Parliament and of the Council of 18th December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), using substances listed in Annex XIV to a/m Regulation will be prohibited starting from the date presented in the Annex as the deadline ("Sunset date"). The prohibition will include usage of pure chemical substances and chemical substances as components of chemical mixtures.

Taking into account the above mentioned requirements we ask you for providing us with an information, if in production process of parts shipped by you to WSK chemical substances listed in Annex XIV to REACH Regulation are used.

Feedback should include:

- name of the substance (from Annex XIV to REACH Regulation)
- list of part numbers, in which production substance is used
- name of the particular part production process.

Due to obligation to provide information about substances contained in products we ask you to provide us also with an information, if parts shipped by you to WSK contain substances from Candidate list (link below). If yes, please, provide us name of the substance and number of the part.
