Dear Suppliers,

Pratt and Whitney will be requiring the deployment and implementation of the new AS9100 quality system supplement, SAE AS13100™ AESQ Quality Management System Requirements for Aero Engine Design and Production Organizations published by the Aerospace Engine Supplier Quality (AESQ) Strategy Group.

As of January 1, 2023, all supplier's supporting Pratt & Whitney will need to be compliant with AS13100 as defined in ASQR-01.

AS13100 was created to replace aero-engine customer-specific quality requirements – leading to simplification and harmonization between engine manufacturer supply chains.

As Pratt & Whitney's partner and key contributor in the success of building Dependable Engines, we are offering a training / Q&A program in 2022 for all Quality Managers (and their staff) within our supply base to participate in. The intent of the program is to ensure suppliers are aware and on track with meeting the new AS13100 specification for the January 1st, 2023 deadline. As our partners in this, we would like to equip every Quality Manager with the resources and guidance to ensure their QMS remains in compliance.
